<u>ITEM TITLE</u> HOUSING ELEMENT UPDATE WORKSHOP IV – SPECIAL WORKSHOP WITH DIRECT STAKEHOLDER ENGAGEMENT AND ASSESSMENT OF INCLUSIONARY HOUSING PROGRAM AS AN AFFORDABLE HOUSING STRATEGY

**SUMMARY** Three City Council Workshops on the Housing Element have been held. The first workshop, on March 11, 2020, focused on the preliminary housing sites inventory. The second workshop, on May 27, 2020, presented the City Council with the concept of inclusionary housing and in-lieu fees. The second workshop was continued to June 24, 2020, and at that meeting presented City Council with built examples of inclusionary housing, a sample inclusionary housing ordinance, and additional information on inclusionary housing in-lieu fees. At the continued second workshop, the City Council directed Staff to meet with housing stakeholders, including the Building Industry Association, to provide feedback on inclusionary housing. At a third workshop on October 28, 2020, Staff reported the findings to the City Council of its stakeholder meetings and the results of a survey on inclusionary housing that the stakeholders completed. At the third workshop the Council directed Staff to convene a special workshop where the City Council could directly engage with these stakeholders and additional stakeholders from the real estate and mortgage industries before considering whether to conduct an inclusionary housing in-lieu fee study.

This special City Council workshop includes all of the market-rate and affordable housing stakeholders with whom Staff had previously met, and also includes new stakeholders from the real estate and mortgage industries (see Attachment A: Stakeholder List). Information on inclusionary housing previously provided to the City Council is via the links herein.

**ENVIRONMENTAL REVIEW** This is a workshop, not subject to CEQA pursuant to Section 15306, titled "Information Collection". Compliance with the Environmental Quality Act (CEQA) would be required for the adoption of the Housing Element.

**FINANCIAL STATEMENT** Should the City Council decide to move forward with an inclusionary housing program, an inclusionary housing in-lieu fee study would need to be completed for which a Request for Proposals (RFP) would be required. Based on initial outreach to various fiscal analysis firms, it is estimated that such a fee study would cost roughly \$37,500.
